

BOOKING POLICY

1. A Shareholder is entitled to special privileges including:
 - Room rates during the winter season at a substantial discount to commercial rates
 - Shareholder Early Bird rates
2. Nominated friends of a Shareholder are entitled to certain privileges including:
 - Room rates during the winter season at a discount to commercial rates
 - Friend Early Bird rates
3. A Shareholder may forego booking privileges and assign these privileges to another person for the winter season by notifying the Secretary in writing. Partseason assignments are not permitted.
4. A Shareholder or Friend or person with assigned booking rights is entitled to one room at discount rates. A shareholder who wishes to use more than one share right concurrently, must transfer the right to use the second share to another adult.
5. Winter bookings open at the beginning of March
 - Preference is given to 7-day, then 5-day, then less than 5-day bookings
 - Bookings are based on twin share including at least one adult
6. By making a booking, guests accept the terms and conditions of the lodge
7. All bookings are at the discretion of the Booking Officer and Board.
8. Rooms cannot be held without payment.
9. Full payment is required at the time of booking. The payment is non-refundable and we strongly recommend travel insurance.

LODGE RULES

1. Guests are expected to show consideration for the right of others to the quiet enjoyment of the lodge's facilities.
2. Children must not be left unattended in the lodge during the day or night.
3. Guests are responsible for the behaviour of their children.
4. In the event of unacceptable behaviour of any party, the directors reserve the right to refuse further bookings from the persons concerned.
5. Before going to bed, guests are expected to put away items they have been using and leave the lounge area tidy.
6. The Manager is to be notified of any problem within the Lodge requiring immediate attention.
7. Any comments regarding the operation of the Lodge are invited and should be addressed to the Board of Directors in writing.

LODGE RULES – WINTER

1. On arrival, your room will be available at 3:00pm. On departure, your room is to be vacated by 10:00am.
2. Skis and boots may not be brought into the lounge or into the rooms.
 - The ski storage area is accessed by the back door of the lodge
 - Waxing of skis/boards is not permitted
3. Guests may not enter the kitchen at any time.
4. Non-residents may be invited to the dining table, subject to numbers, but this must be arranged 24 hours beforehand with the Manager and will incur a \$50 per person charge.

LODGE RULES – SUMMER

1. Accommodation is provided on a self-catering basis. Guests supply
 - Food
 - Linen
 - Tea towels
2. BBQs are not permitted due to fire hazard
3. Guests are responsible for cleaning public areas.
 - Vacuum carpets
 - Clean shelving
 - Remove garbage (hoppers are available down the road in the car park)
 - Clean shower, toilet, sink and mirrors
 - Turn off heaters
 - Close windows
4. Breakages are to be reported to the Barina office.
